Miami-Dade County FIRM Panel # 12086C0141L, dated 09/11/2009.

Proposed Work and Purpose: The Roman Catholic Archdiocese of Miami replaced contents and made repairs to

flat roofing, HVAC systems, plaster ceiling, ceiling tiles, and peg boards at the Holy Family Church to return the facility back to pre-disaster condition. Minimization against future flood damages has been met as the facility is located

above the Base Flood Elevation.

Project Alternatives: The alternative that has been considered is the no action alternative. This

alternative is not feasible as the area will remain vulnerable to flood risk, including property damage. Alternate locations were not considered as relocating the facility outside of the floodplain is not feasible as the current cost of repairs outweighs the cost of relocating the facility. Holy Family Church supports the North Miami community by providing a place of worship and relocation may adversely impact

social or economic resources for the community.
